8.2 Golden Valley South Ward Councillor Mr Peter Jinman reported on the following:-

Orange Button Community Scheme – Samaritans, Farmers etc.

"Worcestershire County Council and Herefordshire Council together with the local NHS partners are promoting The Orange Button Community Scheme.

People in Worcestershire and Herefordshire who have suicidal thoughts, or are worried about a friend or family member, will soon be able to get support when they see someone wearing a distinctive orange badge.

Worcestershire County Council and Herefordshire Council together with the local NHS partners are promoting The Orange Button Community Scheme. The Orange Button is worn by people who have relevant training in mental health and suicide prevention. Now trained individuals will be able to make their skills available to help those in need.

The aim of the scheme is to create a community of Orange Button wearers who people can turn to. Orange Button wearers are there to listen, signpost to local support and help reduce stigma by talking openly about suicide.

Anyone across Herefordshire and Worcestershire who has had at least 3 hours of suicide prevention training (or mental health training with suicide prevention content) over the past two years is being asked to consider becoming an Orange Button wearer.

This includes people who have Mental Health First Aid training. Groups likely to have had training include voluntary and community organisations providing public services, workplaces as well as health and care workers, including non-NHS workers."

Herefordshire Council looking at more significant savings and the budget is very tough this year Pay rises are a problem

Herefordshire have the most roads in England

Many residents are in difficulty

School meals are required in the holidays for children

Warm Spaces for the winter e.g. Community Buildings, maybe Doctors Surgeries etc.

Vulnerable and elderly people this winter - "Warm Banks" similar to food banks but for people in fuel poverty, will see public spaces used by residents unable to heat their homes during the colder months. Land line removal in areas that have no mobile coverage is a problem

Phosphates and septic tanks/sewage etc. in the River Wye – joint work in progress with Shropshire, Powys and Monmouthshire to address problems. Soil sampling taking place.

"Dear Sir or Madam,

I write with regard to a concern raised by a parishioner and echoed by many councillors during council discussions.

The issue is that of the increasing number of large lorries travelling on the narrow, winding roads within the parish. They pose a significant hazard to our parishioners and those travelling through the parish as well as making a disproportionate contribution to wear and degradation of the highways.

I have three questions that arise from this concern and wonder whether you could advise.



- 1. Is there any monitoring of the numbers of large lorries in Herefordshire and whether they are increasing in numbers?
- 2. What powers does the Council have, if any, to regulate the travel of large lorries on minor and potentially unsuitable roads? One significant concern is that they are travelling on unsuitable routes as "rat runs" to the detriment of the local environment and population.
- 3. What solutions, or potential solutions, does the Council know of or can suggest in order to reduce this problem?

"Dear Sir or Madam,

I write regarding the proposal to change the route of the local school bus or buses, The Parish Council has been informed that there is a proposal to route the school bus via Mill Lane and through the Dulas Brook ford between Longtown and Abbeydore. We are very concerned as this route is totally unsuitable for a school bus. Mill Lane is a steep, narrow, often single track lane and the ford can swell to unpassable levels during heavy rain.

It may be that this suggestion was made before a route survey was conducted but in case this has not been possible we would like to alert the council to a potentially hazardous and distinctly unwise route for a school bus.
